### **Financial Review:**

- Reviewed 2023 YTD budget and line items as they relate to planned projects
- Reviewed incoming invoices
- Reviewed dues payments (46% paid in full so far)
- Approved purchase of materials for welcome packets (new home owners)
- Approved home buyer transfer fee increase to cover parts and service for those without mailbox keys upon move in; new fee will be \$100

#### **New Business:**

- No parking signs
  - Discussed adding signs to posts at both ends of street to increase awareness of CC&R guidelines re: parking
  - Will discuss in more depth during March board meeting
- Identified that the street sign outside of the main gate is incorrect it is missing Ct in the street name
  - Amber to take lead on researching issue and sign replacement
- Community calendars on web page
  - Agreed to consolidate deactivated board meeting calendar and just keeping the community event calendar live
  - o All community events, including board meetings will be on the community calendar
- Fence replacement: 67<sup>th</sup> Ave E pond (bordering community park)
  - Reviewed quote that Linda sent the board
  - Team decided to proceed with chain link on three sides, the fourth side by the park will be wood
  - Obtain revised quote w /adjustment of chain wrap to wood on that park side (Linda)

- Fix drainage issue in community green
  - o Mini floods reoccurring on edge of community green near homeowner's property
  - HOA has a bid on file, will get 1-2 more before contracting work
    - Dennis will line up contractors to bid the work at same time for efficiency
- Gate call box 'tip sheet' for HOA/ACC
  - Tutorial on how to reset the gate call box when not transmitting
  - Draft to be created by end of Feb for board review prior finalizing (Katie)
- Gate remote tip sheet for residents
  - How to use app, order remotes, etc.
  - Draft to be created by end of Feb for board review prior finalizing and posting on community website (Katie)
- Privacy slats in chain link fences
  - For owners bordering ponds that had new chain link fencing installed and who 'opt-in' for slats
  - Only upon request only

## **Projects in Progress:**

- Reflective tape needs applied to new gate and replaced on front gate (Dennis/Tim)
- Renew license for HOA (non-profit org)
  - Research HOA license for non-profit / \$10 permit (Monica)
  - Linda to give Monica ID # for paperwork
- Tomar fire strobe (FD) head needs repaired
  - Guardian Gate picked up strobe sending back to manufacturer under warranty
  - o Guardian Gate will install replacement when it arrives
- New homeowner / renter packets
  - Packets for recent home purchasers / renters are being prepared (Monica)
  - o Six new movers into the community within the last couple months
- ACC
  - Evaluated ACC volunteer engagement may need to ask for additional volunteers;
    discuss in March meeting
  - Reviewed ACC rounds and owners/renters who need communication re: reminder of CC&R guidelines
