- Reviewed 2023 YTD budget and line items as they relate to current and planned projects

- Dues
  - 2023: collection is at 89%
  - Board voted on and unanimously approved the 2024 dues assessment; amount will be shared at the annual budget meeting on 11/8
- 2024 Budget
  - Reviewed 2024 draft budget the board unanimously approved
  - The annual community budget meeting will be held on 11/8 (review 2023 YTD and 2024 budgets)
- Will put additional \$20k of reserve funds into a CD for higher interest rate
  - Working on gathering requirements to open a new CD

#### New

- HOA Board Positions
  - President
    - Dennis Nathan resigned last month
    - The board unanimously approved Monica Davenport to move from the Vice President to President position effective immediately
      - As current president, Monica Davenport will be added to Umpqua bank accounts and Linda Bowers (former president, prior to Dennis Nathan) will be removed
  - o Vice President
    - Position vacated when Monica Davenport was voted into the President role
    - The board unanimously approved Loree Latona to move from the Sergeant in Arms to Vice President position effective immediately
  - Secretary
    - Amber Bishop gave notice and her last month serving on the board will be December 2023
  - The board will start searching for replacements to backfill the Sergeant in Arms and Secretary positions
